

## **Arizona State University Tuition Proposal FAQ for Academic Year 2023-2024**

### **Why is ASU adjusting tuition?**

Arizona State University recognizes that any decision to advance tuition adjustments needs to be assessed and determined with attention to the potential impact to students and their families. In every case, changes to tuition take into account the resources involved in sustaining and improving the effective delivery of the world-class, high-value education expected from ASU. As learner needs, interests and expectations change over time, ASU listens and responds by expanding access to its offerings, developing and maintaining innovative and useful programs and services, and embracing new technology. All of this occurs within the framework of the ASU charter, and specifically, our responsibility for the social, economic, cultural and overall well-being of those we serve as a National Service University.

### **How does ASU tuition compare to other universities?**

ASU continues to be the best college value in Arizona, with the lowest tuition among the three state universities and one of the lowest among Pac-12 universities. ASU continues its designation as one of the “best buy” college values in the U.S, for providing a top-tier, competitive higher education experience while maintaining its affordability.

### **Does this tuition increase follow President Crow’s pledge not to raise Arizona resident tuition by more than 3 percent a year?**

Yes. Twelve years ago, President Crow vowed to keep future ASU tuition adjustments to 3% or less for Arizona resident undergraduate students and as close to zero as possible. There was a modest tuition increase for ASU students during the 2022-2023 academic year. The proposed tuition adjustments for the 2023-2024 academic year remain within ASU’s tuition commitment.

## **RESIDENT CAMPUS IMMERSION UNDERGRADUATE STUDENTS**

### **What are the proposed changes to ASU tuition for resident campus immersion students?**

The proposed base tuition increase for Arizona resident, campus immersion students at ASU’s four metro campuses for FY24 is 3% or \$330.

### **Are there proposed college-specific changes to ASU program fees for campus immersion undergraduate students?**

Yes. The proposed fee adjustments are \$0-\$30/year for resident students and \$0-\$60/academic year for non-resident students.

## **RESIDENT CAMPUS IMMERSION GRADUATE STUDENTS**

### **What are the proposed changes to ASU tuition for resident campus immersion graduate students?**

The proposed base tuition increase for Arizona resident campus immersion graduate students is 3% or \$362.

### **ASU POLYTECHNIC CAMPUS AND NEW COLLEGE STUDENTS**

#### **What are the proposed changes to ASU tuition for ASU Polytechnic and New College students?**

First-and second-year students at the ASU Polytechnic School and New College will continue to have a 10% reduction of base tuition. That would lower base tuition by \$296 for resident undergraduate students; \$1,348 for nonresident undergraduate students; and \$1,476 for international undergraduate students.

### **NON-RESIDENT CAMPUS IMMERSION UNDERGRADUATE STUDENTS**

#### **What are the proposed changes to ASU tuition for non-resident campus immersion undergraduate students?**

The proposed base tuition increase for non-resident campus immersion undergraduate students is 5% or \$1,498.

### **NON-RESIDENT CAMPUS IMMERSION GRADUATE STUDENTS**

#### **What are the proposed changes to ASU tuition for non-resident campus immersion graduate students?**

The proposed base tuition increase for non-resident campus immersion graduate students is 5% or \$1,634.

### **INTERNATIONAL CAMPUS IMMERSION UNDERGRADUATE STUDENTS**

#### **What are the proposed changes to ASU tuition for international campus immersion undergraduate students?**

The proposed base tuition increase for international campus immersion undergraduate students is 5% or \$1,638.

### **INTERNATIONAL CAMPUS IMMERSION GRADUATE STUDENTS**

#### **What are the proposed changes to ASU tuition for international campus immersion graduate students?**

The proposed base tuition increase for international campus immersion graduate students is 5% or \$1,764.

### **DIGITAL IMMERSION STUDENTS**

#### **What are the proposed changes to ASU tuition for digital immersion students?**

The proposed tuition adjustment for digital immersion students is 2% per credit hour or \$11/ per credit with a continued cap on Arizona resident undergraduate and graduate students equivalent to the full-time, campus immersion tuition rate per semester. Base tuition for digital immersion, non-resident students is billed per credit hour with no cap.

**Are there proposed college-specific fee changes for digital immersion undergraduate students?**

Yes. The proposed fee adjustment for digital immersion students is 2% or \$0-\$2/credit.

**Are there proposed college fee changes for campus-immersion and digital immersion undergraduate students?**

Yes. The proposed college fee adjustments are \$0-\$30/year for campus immersion, resident undergraduate students and \$0-\$60/year for campus immersion, non-resident undergraduate students.

The proposed college fee adjustment is \$0-\$2/credit increase for digital immersion undergraduate students.

**ASU GRADUATE STUDENTS**

**Are there proposed program-specific fee changes for ASU graduate students?**

**Are there any proposed support fee changes for ASU undergraduate students?**

Yes. A new undergraduate Transfer Student Enrollment Services fee of \$250/semester is proposed. The new fee would be implemented in spring 2024.

**Are there other fee changes for ASU undergraduate and graduate students?**

Yes. Other proposed changes to student fees include a \$25/semester increase to the Health and Wellness Fee, and a \$25/semester increase in the Student Services Facility Fee.

**Are there any proposed support fee changes for ASU graduate students?**

Yes. A new Graduate Student Enrollment Services fee of \$250/semester is proposed. The new fee would be implemented in spring 2024.
